

CHARTER ORDINANCE NO. 11

A CHARTER ORDINANCE REPEALING CHARTER ORDINANCE NO. 8, EXEMPTING THE CITY FROM A PROTION OF K.S.A. 15-209 REGARDING THE QUALIFICATION OF CITY CLERK AND UTILITY SUPERINTENDENT

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME, KANSAS:

Section 1. The City of Burlingame, Kansas, by the power vested in it under Article 12, Section 5 of the constitution of the State of Kansas, hereby elects to exempt itself and make inapplicable to it, the provisions of K.S.A. 15-209 insofar as said statute may require that a city clerk or the utilities superintendent, if appointed, be a qualified elector of said city.

Section 2: The city clerk of the City of Burlingame, Kansas, need not be a qualified elector of the City of Burlingame, Kansas, and may reside outside of the city limits of Burlingame. City Clerk shall reside within Osage County and be a qualified elector of Osage County.

Section 3. The City Superintendent of Utilities of the City of Burlingame, Kansas, need not be a qualified elector of the City of Burlingame, Kansas, and may reside outside of the city limits of Burlingame. City Superintendent shall reside within Osage County and be a qualified elector of Osage County.

Section 4. Charter Ordinance No. 8 of the City of Burlingame is hereby repealed.

Section 5. This Charter Ordinance shall be published once each week for two consecutive weeks in the official City newspaper.

Section 6. This Charter Ordinance shall take effect 61 days after final publication unless a sufficient petition for a referendum is filed, requiring a referendum to be held on the ordinance as provided in Article 12, Section 5 of the constitution of the State of Kansas, in which case this Charter Ordinance shall become effective upon approval by a majority of the electors voting thereon.
