

ORDINANCE NO. 1966

AN ORDINANCE AMENDING THE CODE OF THE CITY OF BURLINGAME, KANSAS BY ADDING A SECTION TO CHAPTER XII PUBLIC PROPERTY ARTICLE I CITY PARKS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME, KANSAS:

SECTION 1. Chapter XII Public Property Article I City Parks of the Code of the City of Burlingame, Kansas, is hereby amended by adding a new section which reads as follows:

12-113. It shall be unlawful for any person to bring or to have in their possession or control any animal while upon City property designated for use as ballparks including the spectator area, parking, concession area and the area adjacent to the ballparks commonly used by participants or spectators of activities at the ballparks. Provided this section shall not be applicable to any dog that is in the control and possession of a visually handicapped person and is used and required for the assistance of that visually handicapped person.

SECTION 2. This Ordinance shall be effective upon it's passage by the governing body, approval by the Mayor, and publication in the official City newspaper.
