7. Unfinished Business

a. Trash bid review – Opening of bids

Mayor Mullinix opened the two bids from Waste Management and LRS

Waste Management proposed rates are:

Residential 96-gallon cart	\$17.00 per month plus city fee
Extra Cart	\$10.00 per month plus city fee
Commercial 2-yard dumpster 1x week	\$50.00 per month plus city fee
Commercial 2-yard dumpster 2x week	\$100.00

LRS proposed rates are

Residential 96-gallon cart	\$27.00 per month plus city fee
Extra Cart	\$10.00 per month plus city fee
Commercial 2-yard dumpster 1x week	\$95.00 per month plus city fee
Commercial 2-yard dumpster 2x week	not an option

Both proposals are on file for Council and community to review at City Hall. Awarding of the bid will be at the 9/3/24 meeting.

b. Safe Street Grant Update

City Clerk Atchison reminded the Council members she will need their letters of support by August 23rd for the grant. A map of the proposed city sidewalks on Santa Fe, around the park and disc golf course was sent to the Grant writer as well as pictures of the areas.

c. Burlingame MIH Grant – Quinton Robert

Quinton Robert discussed the items needed for the grant to be completed by 9/15/2024. They are a resolution from the council and letters of support from the community.

- There are two grants associated with the housing. They are the MIH Grant and the Tax Housing Investor Credit and MIH Grant. Twenty new homes are needed countywide.
- Need to push on County Treasurer for a property tax sale. The average home is \$300,000.
- The resident who purchases the home must live in it for some time or they will have to pay the grant back.

Councilmember Middleton made the motion to have Attorney Godderz draft the resolution to be reviewed and approved at the next meeting and to approve the payment of the fee associated with the grant. Councilmember Curtis seconded the motion.
