ORDINANCE NO. 1726

AN ORDINANCE RELATING TO THE GAS UTILITY SYSTEM OF THE CITY OF BURLINGAME, SETTING RATES AND CHARGES FOR SERVICE RECEIVED FROM SAID SYSTEM AND REPEALING ORDINANCE NOS. 1554 AND 1555.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME:

SECTION 1. That the municipal gas department, effective with the monthly billing for August 1995, shall furnish natural gas consumed or used within and outside the corporate limits at the following minimum monthly charges:

Special Benefit Districts	\$7.50
All Other Customers	\$5.00

SECTION 2. That the municipal gas department, effective with the monthly billing for August 1995, shall furnish natural gas consumed or used within and outside the corporate limits at the following monthly rates and thereby eliminating the seasonal rate structure:

Special Benefit Districts	\$4.76/mcf
KCC Jurisdictional	\$3.872/mcf
All Other Customers	\$4.66/mcf

SECTION 3. That the term special benefit district shall mean all gas utility lines laid by the City of Burlingame outside of the corporate limits for which a special rate structure has been set up and shall include the Fostoria gas line and the term KCC jurisdictional shall mean all gas utility lines beyond 3 mile zone of corporate limits.

SECTION 4. That Ordinance Nos. 1554 and 1555 are hereby repealed.

SECTION 5. That this ordinance shall take effect and be in force from and after its passage, approval and publication in the official City newspaper.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME:

SECTION 1. That the municipal gas department, effective with the monthly billing for August 1995, shall furnish natural gas consumed or used within and outside the corporate limits at the following minimum monthly charges:

Special Benefit Districts	\$7.50
All Other Customers	\$5.00

SECTION 2. That the municipal gas department, effective with the monthly billing for August 1995, shall furnish natural gas consumed or used within and outside the corporate limits at the following monthly rates and thereby eliminating the seasonal rate structure:

Special Benefit Districts	\$4.76/mcf
KCC Jurisdictional	\$3.872/mcf
All Other Customers	\$4.66/mcf

SECTION 3. That the term special benefit district shall mean all gas utility lines laid by the City of Burlingame outside of the corporate limits for which a special rate structure has been set up and shall include the Fostoria gas line and the term KCC jurisdictional shall mean all gas utility lines beyond 3 mile zone of corporate limits.

SECTION 4. That Ordinance Nos. 1554 and 1555 are hereby repealed.

SECTION 5. That this ordinance shall take effect and be in force from and after its passage, approval and publication in the official City newspaper.
