

ORDINANCE NO. 1894

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF BURLINGAME, KANSAS, IN CONFORMITY WITH K.S.A. 12-520, AS AMENDED.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME, KANSAS:

Section 1: The following described land, to-wit:

A tract commencing at the Northwest corner of the East  $\frac{1}{2}$  of the Southeast  $\frac{1}{4}$  of Section 10, Township 15 South, Range 14 East of the Sixth P.M., Osage County, KS thence East along the North Line of the said E  $\frac{1}{2}$ , SE  $\frac{1}{4}$  for a distance of 725.40 feet; thence South 129' to the center of Switzler Creek; thence in a Southeasterly direction along the center line of said Switzler Creek to a point 1863.00 feet North and 40 feet west of the Southeast corner of said section 10; thence North 89 degrees 44 minutes 34 seconds West a distance of 962.87 feet to a point in an existing fence; thence North 05 degrees 27 minutes 22 seconds East a distance of 106.50 feet along said fence; thence North 89 degrees 26 minutes 00 seconds West a distance of 335.00 feet to the West line of the said E  $\frac{1}{2}$ , SE  $\frac{1}{4}$ ; thence North along the said West line for a distance of 706.20 feet to the Point of Commencement and also all that part of the Northwest  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  of said Section 10, Township 15 South, Range 14 East lying East of South Osage Road and containing 15.49 acres, according to the Osage County Assessor's Office. The above tract is subject to an easement for ingress and egress 20 feet in width along the West 200 feet of the North line.

meeting one or more of the classifications for annexation prescribed by K.S.A. 12-520, as amended, is hereby annexed and made a part of the City of Burlingame, Kansas.

Section 2: This ordinance shall take effect and be in force from and after its passage by the Governing Body approval by the Mayor and publication in the official City newspaper.


