2. Discussion regarding the property at 105 East Santa Fe

- Building Inspector Welch discussed his inspection of the property at 105 East Santa Fe. He feels repairs are needed and the building is unsafe at this time.
- Austin Masters asked if other buildings with damage from the recent storm are also being addressed. The answer was "Yes", but the city has the potential for liability as per our ordinance.
- Mr. Masters advised he has plans to fix the building and has had an engineer review. He will forward a copy of the engineer report to Building Inspector Welch.
- Attorney Godderz advised since the inspection has been brought to the City Council's attention the city has potential for liability. He must advise the City to develop with the owner a plan to fix or tear down.
- City Clerk Atchison gave Mr. Masters information on the Emergency Heal Grant
- Offer Baker agreed to use the drone to fly over the building to check on the roof damage.
- Councilmember Burns made the motion to allow Austin Masters to get with Police Chief Baker to use the drone to get pictures of the roof and to work with Brett Waggoner on the Emergency Heal Grant. Councilmember Middleton seconded the motion

3. Consider the motion to approve the Resolution to do the abatement at 201 East Santa Fe

- Building Inspector Welch advised we need to allow the 180 days for the fence to be constructed and the building to be moved onto the property. This will need to be done by 10/11/24.
- Building Inspector Welch will discuss with the property owner to move the trailer in front of the building which is causing an issue for people to be able to view traffic coming from the East on Santa Fe.

4. Discussion regarding the property at 327 West Hall

- Joseph Ebert discussed the future clean-up efforts and plans for the mobile home at this property. He asked the council for an extension until 9/16/24.
- Councilmember Middleton made the motion to grant the extension until 9/16/24 with the condition if unable to fix it, the council will be advised. Councilmember Burns seconded the motion.

5. Discussion on the property at 620 South Topeka


