

ORDINANCE NO. 1677

AN ORDINANCE ESTABLISHING A PLANNING COMMISSION FOR THE CITY OF BURLINGAME, KANSAS:

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME, KANSAS:

SECTION 1. Planning Commission.

(A) PLANNING COMMISSION: QUALIFICATIONS.

There is hereby established for the City of Burlingame, Kansas, a city planning commission for such City, which shall consist of five (5) electors that shall reside within the corporate limits of said City, all to be appointed by the Mayor, with the consent of the council. The members of the commission first appointed shall serve respectively for terms of one (1) year, two (2) years and three (3) years, divided equally, or as nearly equal as possible, between these terms. Thereafter, members shall be appointed for terms of three (3) years each. Vacancies shall be filled by appointment for the unexpired term. Members of the planning commission shall serve without compensation.

(B) PLANNING COMMISSION; MEETINGS; QUORUM.

The members of the city planning commission shall meet at least once a month at such time and place as they may fix by resolution. They shall select one of their number as chairman and one as vice-chairman who shall serve one (1) year and until their successor has been selected. A secretary shall also be selected who may or may not be a member of the commission. Special meetings may be called at any time by the chairman, or in the chairman's absence, by the vice-chairman. Any majority of the commission shall constitute a quorum for the transaction of business. The commission shall cause a proper record to be kept of its proceedings.

(C) PLANNING COMMISSION: POWERS; DUTIES. The planning commission and City governing body shall have all the powers and duties applicable to them as set forth in Article 7 of Chapter 12 of Kansas Statutes Annotated, and such other powers and duties as are now or may hereafter be prescribed by law.

SECTION 2. Repeal of conflicting ordinances. All

ordinances or parts of ordinances in conflict herewith are hereby repealed.

This ordinance shall take effect and be in force from and after its passage, approval and publication in the official newspaper of said City.

(C) PLANNING COMMISSION: POWERS; DUTIES. The planning commission and City governing body shall have all the powers and duties applicable to them as set forth in Article 7 of Chapter 12 of Kansas Statutes Annotated, and such other powers and duties as are now or may hereafter be prescribed by law.

SECTION 2. Repeal of conflicting ordinances. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

This ordinance shall take effect and be in force from and after its passage, approval and publication in the official newspaper of said City.

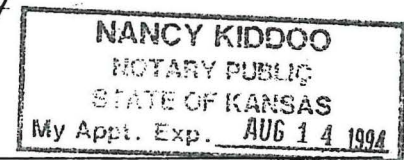
