<u>G. Discussion from Brandi Shaffer – Librarian regarding the CDBG Community Facilities</u> Grant

The total amount of the Grant will be \$650,000 for the proposed addition to the library building. A 20% match is required. The library will be pursuing matching funds from Jones Trust and other Grants. This grant will be at "No" cost to the city other than the City Clerk's time to assist with the application and administration of the grant. Mayor Mullinix and other Councilmembers discussed the increased cost to the insurance and utilities. Other questions asked:

- 1. Would the community building be open for others to rent?
- 2. If rented, how will the rent money received be distributed?
- 3. If the city approved this application for community building, would it cause a problem if the city wanted to build a bigger community building? Brett Waggoner GAS advised this would not be a problem for future grants for the city. The Librarian, Brandi Shaffer advised she did not have all the answers at this time. Brett Waggoner GAS advised the city, and library will sign an Interlocal Agreement as part of the grant process which will outline any of the questions.

Mayor Mullinix asked City Clerk Atchison to review our current insurance policy to see if contents are being covered by the city or just the current building. She would also like a proposed estimate on the increased cost for the new building.

9. Staff Reports

A. Building Inspector Dubois

- He is currently working with Larry Arnold to do the electrical inspections.
- He had to accompany Chief Baker on a welfare check of a home. The home is in bad shape and residents need to be moved out by the 17th of December and repairs will be made to the property at 306 West Schuyler.
- He is currently monitoring the work in progress for a new deck and the old Bell Mine at 105 West Santa Fe.
- Ongoing discussion with the property owner at 116 and 118 West Santa Fe. May 1, 2026, has been given for the windows and doors to be installed as well as the tuck point to be completed. The property owner advised he wants to sell both buildings.
