

ORDINANCE NO. 1999

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF BURLINGAME, KANSAS, IN CONFORMITY WITH K.S.A. 12-520, AS AMENDED.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME, KANSAS:

Section 1: The following described land, to-wit:

That part of the Southwest Quarter of Section 10 and the Northwest Quarter of Section 15, Township 15 South, Range 14 East of the Sixth Principal Meridian, Osage County, Kansas, described as follows:

Beginning at the northeast corner of said Northwest Quarter; thence along the east line of said Northwest Quarter on an assumed bearing of South 0 degrees 06 minutes 15 seconds West, 40.00 feet to the south right-of-way line of K-31 Highway; thence along said south right-of-way line and being parallel with the north line of said Northwest Quarter, North 89 degrees 55 minutes 32 seconds West, 788.01 feet; thence at right angles North 0 degrees 04 minutes 28 seconds East, 80.00 feet to the north right-of-way line of K-31 Highway; thence along said north right-of-way line South 89 degrees 55 minutes 32 seconds East, 787.79 feet to the east line of said Southwest Quarter; thence along said east line South 0 degrees 16 minutes 01 seconds East, 40.00 feet to the point of beginning, containing 1.447 acres, more or less,

and

That part of the Southwest Quarter of Section 10 Township 15 South, Range 14 East of the Sixth Principal Meridian, Osage County, Kansas, described as follows:


Commencing at the southeast corner of said Southwest Quarter; thence along the east line of said Southwest Quarter on an assumed bearing of North 0 degrees 16 minutes 01 seconds West, 40.00 feet to the north right-of-way of K-31 Highway and being the point of beginning; thence, along said right-of-way line North 89 degrees 55 minutes 32 seconds West, 787.79

feet; thence, at right angles North 0 degrees 04 minutes 28 seconds East, 150.00 feet; thence parallel with the south line of said Southwest Quarter, South 89 degrees 55 minutes 32 seconds East, 786.90 feet to the east line of said Southwest Quarter; thence along said east line South 0 degrees 16 minutes 01 seconds East 150.00 feet to the point of beginning, containing 2.711 acres, more or less,

meeting one or more of the classifications for annexation prescribed by K.S.A. 12-520, as amended, is hereby annexed and made a part of the City of Burlingame, Kansas.

Section 2: This ordinance shall take effect and be in force from and after its passage by the Governing Body approval by the Mayor and publication in the official City newspaper.

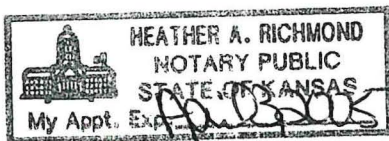

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF BURLINGAME, KANSAS, IN CONFORMITY WITH K.S.A. 12-250, AS AMENDED

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME, KANSAS

Section 1. The following described land, to-wit:

That part of the Southwest Quarter of Section 10 and the Northwest Quarter of Section 15, Township 15 South, Range 14 East of the Sixth Principal Meridian, Osage County, Kansas, described as follows:

Beginning at the northeast corner of said Northwest Quarter; thence along the east line of said Northwest Quarter on an assumed bearing of South 0 degrees 06 minutes 15 seconds West, 40.00 feet to the south right-of-way line of K-31 Highway; thence along said south right-of-way line and being parallel with the north line of said Northwest Quarter, North 89 degrees 55 minutes 32 seconds West, 799.01 feet; thence at right angles North 0 degrees 04 minutes 28 seconds East, 80.00 feet to the north right-of-way line of K-31 Highway; thence along said north right-of-way line South 89 degrees 55 minutes 32 seconds East, 797.79 feet to the east line of said Southwest Quarter; thence along said east line South 0 degrees 16 minutes 01 seconds East, 40.00 feet to the point of beginning, containing 1.447 acres, more or less,

and

That part of the Southwest Quarter of Section 10 Township 15 South, Range 14 East of the Sixth Principal Meridian, Osage County, Kansas, described as follows:

Commencing at the southeast corner of said Southwest Quarter; thence along the east line of said Southwest Quarter on an assumed bearing of North 0 degrees 16 minutes 01 seconds West, 40.00 feet to the north right-of-way of K-31 Highway and being the point of beginning; thence, along said right-of-way line North 89 degrees 55 minutes 32 seconds West, 787.79 feet; thence, at right angles North 0 degrees 04 minutes 28 seconds East, 150.00 feet; thence parallel with the south line of said Southwest Quarter, South 89 degrees 55 minutes 32 seconds East, 786.90 feet to the east line of said Southwest Quarter; thence along said east line South 0 degrees 16 minutes 01 seconds East 150.00 feet to the point of beginning, containing 2.771 acres, more or less

meeting one or more of the classifications for annexation prescribed by K.S.A. 12-520, as amended, is hereby annexed and made a part of the City of Burlingame, Kansas.

Section 2: This ordinance shall take effect and be in force from and after its passage by the Governing Body approval by the Mayor and publication in the official City newspaper.
