

ORDINANCE NO. 2106

AN ORDINANCE VACATING STREETS AND ALLEYS IN THE VICINITY OF CHASE AVENUE AND DELAWARE STREET, WITHIN THE CITY OF BURLINGAME, OSAGE COUNTY KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME:

SECTION 1. The Governing Body of the City of Burlingame, Kansas for good cause and by its own application does hereby vacate the following streets and alleys to-wit:

All of Chase Avenue lying South and East of the center line of the abandoned right-of-way of the Atchison, Topeka and Santa Fe Railway Company, formerly the Burlingame and Northwest Railway Company, formerly the Manhattan, Alma and Burlingame Railway Company to the western beginning of the southern portion of Lot 1, Block 12, in the Original Town of Burlingame, according to the recorded Plat thereof and the western beginning of the northern portion of Lot 22, Block 1, in the Original Town of Burlingame, according to the recorded Plat thereof.

All of Delaware Street lying South and East of the center line of the abandoned right-of-way of the Atchison, Topeka and Santa Fe Railway Company, formerly the Burlingame and Northwest Railway Company, formerly the Manhattan, Alma and Burlingame Railway Company to the northern line of Banks Avenue.

All of the alley in Block 12 lying South and East of the center line of the abandoned right-of-way of the Atchison, Topeka and Santa Fe Railway Company, formerly the Burlingame and Northwest Railway Company, formerly the Manhattan, Alma and Burlingame Railway Company to the western beginning of the southern portion of Lot 22, Block 12, in the Original Town of Burlingame Plat and the western beginning of the southern portion of Lot 1, Block 12, in the Original Town of Burlingame, according to the recorded Plat thereof.


All of the alley in Block 1, in the Original Town of Burlingame according to the recorded Plat thereof.

SECTION 2. This vacation is subject to the existing rights of all present, public, or private utilities or uses located under, on, upon, or over said described real estate.



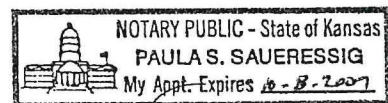
