City Superintendent Holman went over where the funds will come from for the new truck. The Electric Fund Transfer of \$25,000 will not transfer out of electric fund to general in 2024, \$10,000 from the Equipment Fund in Electric and \$10,000 from the Capital Outlay in Electric for a total of \$45,000. Then in 2025 a motion will be made for the proper accounting of this loan payment.

Councilmember Burns made the motion to do a loan with the Bank of Burlingame to purchase the Digger Truck from Altec Nuecco, LLC for \$176,900. Councilmember Kohlman seconded the motion.
