

ORDINANCE NO. 1920

**AN ORDINANCE AMENDING THE BURLINGAME CODE REQUIREMENTS FOR PAYMENT OF UTILITY CONNECTION FEES.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME, KANSAS:**

**Section 1: Section 15-207** of the Code of the City of Burlingame is hereby amended to read as follows:

**CONNECTION FEES.** The fees for connection to the city waterworks system shall be as follows:

- (a) Residential Customers - \$400.
- (b) Commercial and Industrial Customers - Amount equal to the cost to the city.

The fees for connection may be waived by the City for any new residential construction within the corporate limits commenced after the effective date of this ordinance. Application for a waiver of connection fees and approval by the governing body must be made prior to commencement of construction.

**Section 2: Section 15-403** of the Code of the City of Burlingame is hereby amended to read as follows:

**CONNECTION FEE.** (a) No person shall uncover, make any connections with or opening into, use, alter, or disturb any public sewer or appurtenance thereof without first obtaining a written permission from the city. (b) There shall be a \$250.00 connection fee to cover the inspection, labor and materials. In addition there shall be a \$25.00 tap charge.

The fees for connection may be waived by the City for any new residential construction within the corporate limits commenced after the effective date of this ordinance. Application for a waiver of connection fees and approval by the governing body must be made prior to commencement of construction.

**Section 3: Section 15-704A** of the Code of the City of


Burlingame is hereby amended to read as follows:

**RATES AND CHARGES.** A connection fee of \$400.00 shall be paid by residential customers for new services. A connection fee at cost to the city shall be paid by commercial and industrial customers.

The fees for connection may be waived by the City for any new residential construction within the corporate limits commenced after the effective date of this ordinance. Application for a waiver of connection fees and approval by the governing body must be made prior to commencement of construction.

This Ordinance shall be in full force and effect from and after its passage by the governing body, approval by the Mayor, and publication in the official city newspaper.





### ORDINANCE NO. 1920

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURLINGAME, KANSAS:

Section 1: Section 15-207 of the Code of the City of Burlingame is hereby amended to read as follows:

**CONNECTION FEES.** The fees for connection to the city water works system shall be as follows:

(a) Residential Customers - \$400.

(b) Commercial and Industrial Customers - Amount equal to the cost to the city.

The fees for connection may be waived by the City for any new residential construction within the corporate limits commenced after the effective date of this ordinance. Application for a waiver of connection fees and approval by the governing body must be made prior to commencement of construction.

Section 2: Section 15-403 of the Code of the City of Burlingame is hereby amended to read as follows:

**CONNECTION FEE.** (a) No person shall uncover, make any connections with or opening into, use, alter, or disturb any public sewer or appurtenance thereof without first obtaining a written permission from the city. (b) There shall be a \$250.00 connection fee to cover the inspection, labor and materials. In addition there shall be a \$25.00 tap charge.

The fees for connection may be waived by the City for any new residential construction within the corporate limits commenced after the effective date of this ordinance. Application for a waiver of connection fees and approval by the governing body must be made prior to commencement of construction.

Section 3: Section 15-704A of the Code of the City of Burlingame is hereby amended to read as follows:

**RATES AND CHARGES.** A connection fee of \$400.00 shall be paid by residential customers for new services. A connection fee at cost to the city shall be paid by commercial and industrial customers.

The fees for connection may be waived by the City for any new residential construction within the corporate limits commenced after the effective date of this ordinance. Application for a waiver of connection fees and approval by the governing body must be made prior to commencement of construction.

This Ordinance shall be in full force and effect from and after its passage by the governing body, approval by the Mayor, and publication in the official city newspaper.
