B. Code Enforcement

1. Update on property at 111 West Santa Fe (Funeral Home)

The property was deeded over to Troy Gray % T&L Petfood on 9/30/25.

Councilmember Curtis made the motion to send insurance holding payment of \$56,556.62 to Price Family Funeral Home. Councilmember Strohm seconded the motion.

2. Update on repairs at 620 S. Topeka

Building Inspector Dubois advised the repairs are underway on the home. He will continue to monitor.

3. Update to the property at 221 East Fremont

Councilmember Strohm made the motion to start the condemnation process and for Attorney Godderz to draft a resolution to be reviewed at the next meeting. Councilmember Curtis seconded the motion.

4. Discussion regarding the property at 105 East Santa Fe

Mr. Masters advised they are going out for bids. Bids to be opened on 11/12/2025. He would like to apply for the HEAL Grant with the City's approval. Councilmember Curtis made the motion for Mr. Masters to contact Brett Waggoner to move forward with the HEAL Grant. Councilmember Middleton seconded the motion.

5. Discussion regarding the removal of the car on the property at 514 S. Peoria

Police Chief Baker advised the car has not been removed. No more extensions for removal should be granted. He will be issuing a citation to the property owner to appear in court.

6. Update on the properties at 116 and 118 West Santa Fe

Building Inspector Dubois recapped his conversation with Mr. Ingalla. He will follow up with him during the next two weeks to get a firm timeline for the repairs and the removal of the scaffolding.

7. Update for the repairs at 109 West Santa Fe.

8. Update to the old Chicken Coop and trees growing out of building

Building Inspector Dubois advised he had discussed with the property owner and was assured the trees will be removed.

9. Electrical Inspections

Building Inspector reviewed the need for Electrical Inspections to be done by an electrician. The Council asked Mr. Dubois to get some estimates from two or three electricians on the cost to do inspections.

C. Update on the repairs of the underground feeder cable at the Power Plant

Power Plant Superintendent Gallaway advised it would be three to four weeks before completion. There will be three circuits replaced. Power Plant Superintendent Gallaway will follow up with adjuster on how to receive the payment for the repairs.

D. Committee Update on 250th with Burlingame, CA

Councilmember Curtis advised she had sent a letter to Michael Browning, Vice Mayor, to start a discussion on what would be the best activities between the two cities.

<u>E. Discussion regarding the replacement of the building behind Library for Christmas</u> <u>Decoration storage.</u>

Councilmember Strohm made the motion to purchase the building from Legacy Building for \$10,152 with \$4852.94 coming from the Pool Fund (06) and the balance of \$5499.06 from the Infrastructure Fund (11). Councilmember Curtis seconded the motion.

Mayor Mullinix was tiebreaker with a Yes Vote.

8. New Business

A. Discussion regarding the change to the lock on the North Council Room Door

Councilmember Strohm will check on the requirements regarding occupancy and emergency exit with the Fire Marshal

B. Consider the motion to use KCamp Grant of \$2000 towards the purchase of barricades and safety cones.

Councilmember Burns made the motion for City Clerk Atchison and City Foreman Bond to find sets of barricades and cones to come in at \$2000. Councilmember Curtis seconded the motion.
